They are posted to the Ministry of Health & Social welfare and they will attract salary at the rate of D17, 150.00 (Seventeen thousand one hundred and fifty dalasis) per annum on Grade 4.

They will be eligible for confirmation in appointment after three (3) years of service if recommended by your Head of Department and found medically fit.

They would be required to conform to the General Orders, Code of Conduct and Financial Instructions of the Government together with the Public Service Commission Regulations in force from time to time and they are therefore, expected to acquaint themselves with them. They can visit www.psc.gov.gm for details of the above documents.

The appointment is terminable either by Government or by them upon giving a month's notice in writing or on the payment of a month's salary in lieu of notice.

I shall be most grateful if they could let me know through their Head of Department as to whether they accept this offer or not within 14 days with effect from the above date. The offer of appointment will be rescinded after the expiry of the 14 days if no response is received.
