I have much pleasure in informing you that you have been successful in passing the State Enrolled Community Health Nurses State Final Examination held in January, 2017.

2. You are now eligible to apply for admission to this part of the Register on payment of enrolment fee on the application form provided. When your application has been accepted you will be entitled to call yourself a State Enrolled Community Health Nurse and your name will be retained in the register. This Registration and License must be renewed every **THREE YEARS**.

3. It most strongly emphasized that until you have applied for Registration and have been admitted to the Register you are not entitled to call yourself a State Enrolled Community Health Nurse. It will be in your own interest to apply without delay to the Register. On admission to the Register a nurse receives from the above-named Board for a Certificate of Registration.

4. Application for Registration should be on the enclosed form which should be completed in full and returned together with the required fee to the Nurses Board in care of the Registrar of Nurses and Midwives, 1 Hannesson Street, New England, Freetown.

5. Registration number should be obtained before employment.

6. All Registered Nurses **must** be a member of the Sierra Leone Nurses Association.

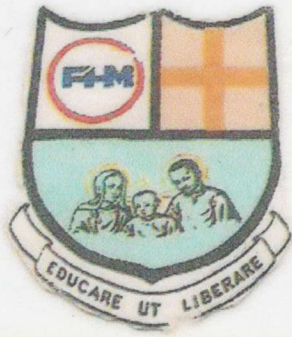
