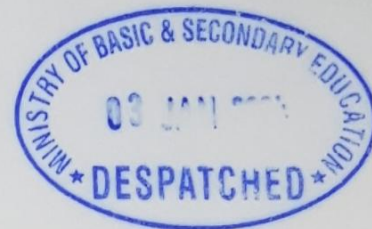

OFFER OF APPOINTMENT


